It has been observed that the clerks to the Advocates do not strictly adopt the dress code and are often found without wearing prescribed uniform as such visiting the Hon'ble High Court in a casual clothing. Such practice causes grave indiscipline and the persons who pose to be clerks to the Advocates are indulging in touting in the Courts/Registry. It is needless to mention that as per Circular No.17 dated 17.2.2005, uniform for clerks to the Advocates has already been prescribed on the suggestions of the Bar Association with approval of Hon'ble the Chief Justice. Copy of the circular as Annexure A is appended.

As such in view of the aforesaid circular, it is reiterated that all the clerks to the Advocates shall maintain the dress code properly and they will be allowed to visit the Registry only when they are found in proper attire. It is further notified that the prescribed badges indicating their names and name of the Advocate with whom they are attached/working, also need to be placed on the left side of their chest.

The description of the uniform prescribed for summer is as under:-

Navy blue Shirt and Pent.

Any breach to the circular shall be viewed seriously.
