Whereas, an advertisement for filling up of three posts of Readers, one each in OM, RBA and ST, in the pay scale of RS. 9300-34800 + Grade Pay 4800/- (Revised Pay Structure) Level-8 Rs. (47600- 151100) was issued vide Notification No. 02/2018 dated 18.04.2018.

Whereas, a written test of eligible candidates for filling up of the above posts was simultaneously held at Jammu Wing and Srinagar Wing of the High Court of Jammu and Kashmir on 23rd of November, 2019.

6. No TA/DA is admissible to the candidates appearing in the Viva voce.
