S/Shri Azad Ahmad Wani and Ghulam Mohammad Parray, Joint Registrars, are placed in the Special Scale of Deputy Registrars in the pay scale of Rs.14300-18300 (pre-revised) [PB-4 37400-67000+GP 8700 (existing pay scale)], notionally with effect from 28.04.2017 and monetarily with effect from the date of this order.

- (ii) The placement of those officers of the cadre of the Bench Secretaries, who rank junior to Shri Pankaj Kumar Gupta (Bench Secretary), in the higher pay scales, shall be subject to the outcome of the regular enquiry pending against Shri Pankaj Kumar Gupta.
