CIRCULAR

No: <u>3 of 2021/RG</u> Dated: <u>04.08.2021</u>

With a view to set a uniform pattern for cause list in both wings of the High Court and in supersession of all previous orders/directions on the subject, Hon'ble the Chief Justice has been pleased to direct as under:

- 1. The Weekly Cause List shall be called as the "Regular Cause List".
- 2. The Daily Cause List issued regarding listing of Fresh matters and such matters which are required to be listed by order of the Court on a day within the week itself, shall be called as the "Supplementary Cause List".
- 3. The Regular Cause List shall be prepared in the following order:
 - I. Matters for pronouncement of Judgment / Order

II. Admission/Order matters

- a. Before Notice matters
- b. After Notice matters

III. Final Hearing matters

- 4. The Regular Cause List shall be prepared day/date wise for each Division Bench/Single Bench in both wings of the High Court and the cases shall be listed in chronological order and serial numbered in ad-seriatim.
- 5. The day/date wise Regular Cause List for all benches shall be compiled for one week i.e. from Monday to Friday/Saturday (as the case may be) with proper index and shall be issued and uploaded on official website of the High Court on immediate preceding Saturday of the week to which it would pertain to.

(Template for Regular Cause List: Suppose on a particular day before a Single Bench there are three cases listed for pronouncement of Judgments/Order, five Before Notice cases and five After Notice cases listed under Admission/Orders column and three cases for Final Hearing, in respect of these matters a template for Regular Cause List including Index is annexed as Annexure-"A" to this Circular.)

6. The Supplementary Cause List for a particular day shall also be prepared in the same order as mentioned at Sr.No.3 above and shall be issued and uploaded on official website of the High Court on previous day or as would be practicable."
