Subject: Select lists of the candidates for the post of Junior Assistants in Subordinate Courts of Kashmir and Jammu Provinces in pursuance to Advertisement Notification Nos. 986 dated 20.02.2014 and 1337 dated 25.03.2015 and operation of waiting list thereof.
