<u>Note:</u>

- i) All the new appointees may be directed to join their place of postings within a period of 15 days from the date of receipt of this Order. In case any appointee fails to join within the stipulated period in that event his/her appointment may be deemed to have cancelled without any further notice.
- ii) All the Presiding Officers, before whom the new appointees have to join may directed to check all testimonials of new appointees and get them verified from the concerned issuing authorities.
- iii) In case the candidate fails to produce requisite qualification and category certificate, the appointment of such candidates may be deemed to be cancelled ab-initio.
- iv) All the Presiding Officers, before whom the new appointees have to join, may be directed to get the character and antecedents of new appointees verified from the Inspector General of Police, CID, Jammu and Kashmir.
- V) The new appointees may be directed to give an undertaking, before the Presiding Officer at the time of their joining in the shape of affidavit duly attested by the Judicial Magistrate 1st Class to the effect that in case any adverse report about his/her character and antecedents is received from the Inspector General of Police, CID, Jammu & Kashmir in that event his/her appointment may be deemed to be cancelled ab-initio and may have no claim on his/her appointment.
- vi) The salary of the new appointees may not be drawn unless a satisfactory report in respect of (ii), (iii) & (iv) above is received by the concerned Presiding Officer.
