Consequent upon the finalization of the selection process and preparation of select lists by the Selection Committee, constituted for recruitment to the posts of the Steno Typists in Subordinate Courts of the State advertised vide High Court Notification No. 323 dated 26.05.2017, and the approval of the recommendations of the Selection Committee by Hon'ble the Chief Justice (Appointing Authority), the following candidates in order of merit are temporarily appointed as Steno Typists in the Pay Scale of Rs. 5200-20200 with Grade Pay of Rs. 2400 in Subordinate Courts of Jammu and Kashmir divisions of the State:



Appointees of Leh and Kargil Districts shall approach to the respective Principal District & Sessions Judges within the aforesaid period. In case any appointee fails to collect his/her posting order within the stipulated time, it shall be presumed that he/she is not interested in taking up the job.


