Consequent upon the recommendations of Hon'ble Committee for Appointment and Promotion of Officials/Officers of the High Court Staff, Hon'ble the Chief Justice has been pleased to approve the following syllabus for filling up of the posts of Translators (Urdu to English), created vide Government vide Order No. 4138-LD(A) of 2012 dated 27-12-2012 in the grade of Rs. 9300-34800 + GP Rs. 4280/- (pre-revised) now revised to Level-6E (35900-113500):

- (i) Written test of 80 marks of 80 minutes duration. The Candidates shall have to appear in the written test comprising of partly objective type questions and partly subjective type questions on the following subjects:
 - (a) Law related objective type 10 questions (each of one mark);
 - (b) Translation of paragraph of 200 words from English to Urdu (20 marks);
 - (c) Translation of paragraph of 200 words from Urdu to English (20 marks);
 - (d) Basic Knowledge related to Computer (20 marks);
 - (e) General Knowledge and Current Affairs (10 questions and each containing one mark).
- (ii) Interview Viva-Voce = 20 Marks.

On the basis of the performance in the written test, the candidates shall be called for Interview/Viva-Voce in order of merit in the ratio of 1:5.

(iii) Candidates qualifying the written examination and called for Interview/Viva-Voce shall also have to appear in computen typing test with speed of not less than 30 words per minute
