Whereas, on the strength of the resolution adopted by the Hon'ble Full Court in its meeting held on 30.06.2022 and in compliance with the Judgment of the Hon'ble Division Bench passed in SWP 1350/2011 titled Arvind Sharma & ors Vs State and ors and SWP No.748/2009 titled Shabir Ahmad Malik and ors Vs State of J&K and ors, the seniority of 2003 batch of Munsiffs (who are presently in service) was re-framed vide High Court order No. 768 of 2022 /RG dated 12.07.2022.

Whereas, during the pendency of above petitions, the entire 2003 batch of Munsiffs got promoted to the post of Civil Judges (Senior Divisions)/ Sub Judges which necessitated re-notifying the seniority and dates of their promotions as Civil Judges (Senior Divisions)/ Sub Judges in consonance with the re-framed seniority.
