5. Age Limit.

(a) **On Deputation**. The Maximum age limit for appointment on deputation shall be 56 years as on the closing date for receipt of application.

(b) <u>On Contract</u>. The maximum age limit for the re-employment on contract basis is 63 years. The gross pension will be deducted from the pay fixed, where applicable.

6. General Information.

(a) Self certified photo copies of all educational and other testimonials & certificates (including the PPO, where necessary) are required to be attached alongwith the application.

(b) Application for deputation will have to be routed through the parent department by the competent authority, alongwith the photocopies of Annual Confidential Report of preceding five years.

(c) Application received after last date due to any reason will not be entertained.

7. The applications for the appointment **on deputation basis** from eligible candidates, who can be spared in the event of their appointment, where necessary, shall be forwarded alongwith '**No Objection Certificate**'. While forwarding the application, a certificate to the effect that no disciplinary action / inquiry is pending or contemplated against the officer / official concerned shall also be furnished.
