

**BOND**

(To be executed on Non-Judicial Stamp of Rs 100/- and attested by a Judicial Magistrate)

I \_\_\_\_\_S/O D/O \_\_\_\_\_R/O\_\_\_\_\_do hereby execute this bond out of my own free will and volition and without any force, coercion, undue influence and representation today the -----day of January 2017 and bind myself to its terms and conditions as under:

1. That my term of engagement with the High Court of J&K as \_\_\_\_\_(Specify name of the post) will be purely of contractual nature for a period of one year or for such extended period as the High Court will determine after initial term of one year completes.
2. That I will not claim any sort of regularization or permanent absorption in the services of the High Court or in the Government service merely on the basis of my working on contractual basis under the present term of engagement.
3. That I will be only eligible to monthly wages which may accrue to me at the end of each month of my working as \_\_\_\_\_(Specify name of the post) with the High Court of J&K for that month and will not claim any other monetary benefit out of such employment.
4. That my services as -----(Specify name of the post) will always be contractual and continuation in the same will be subject to my performance to be evaluated by the High Court from time to time and can be terminated by the High Court before the expiry the contractual period if the High Court finds me not fit for the job because of my poor performance, ill-health or because of my misconduct.
5. That I will give a one month prior notice to the High Court in case of my leaving/resigning from the job.
6. That my engagement as -----(Specify name of the post) by the High Court will be full time and during the term of my engagement as such, I will not carry any other occupation, profession, business or trade either on full time or part time basis.
7. That during my engagement as -----(Specify name of the post) with the High Court, I will work at such place as the High Court deems proper and shall not leave during working hours of the High Court without prior permission of Central Project Coordinator (e-Courts) High Court of J&K.

High Court, I shall perform my duties with due diligence and discipline and shall maintain confidentiality about all matters and information that may come across me during the discharge of my duties.

After one month, I shall be eligible to avail one day casual leave in a single month of completed service.
