**Subject:- Modification to the roster for the week commencing
6th of August, 2018.**

Sir,

Pursuant to the appointment of Smt. Sindhu Sharma and Sh. Rashid Ali Dar as Judges of the High Court of J&K, Hon'ble the Acting Chief Justice has been pleased to direct the following modifications to the roster applicable to Srinagar wing of the High Court for the current week i.e. the week commencing 6th of August, 2018.

1. A Division Bench comprising Hon'ble the Acting Chief Justice and Smt. Sindhu Sharma (Judge designate) is constituted for 7th of August, 2018 for full day and for 8th of August, 2018 for 1st half day to hear all the Division Bench matters.
2. A Division Bench comprising Hon'ble Mr Justice Ali Mohammad Magrey and Sh. Rashid Ali Dar (Judge designate) is constituted on 7th of August 2018 to hear the following matters:
 - 1) All LPAs and Criminal Appeals for Admission, Orders and Hearing.
 - 2) Contempt matters.
 - 3) Judicial Service matters.
 - 4) Specially ordered matters.
 - 5) Writ Petitions directed to be listed before Division Bench.
 - 6) Part Heard and tied matters.
3. A Single Bench to be presided over by Smt. Sindhu Sharma (Judge designate) is constituted w.e.f. 8th to 10th of August, 2018 to hear all

SWP matters upto the year 2014 and All OWP matters upto the year 2014, for Admission, Orders and Hearing during the 2nd half of the aforementioned days.

4. A Single Bench to be presided over by Sh. Rashid Ali Dar (Judge designate) is constituted w.e.f. 8th to 10th of August to hear all Civil, Criminal and Arbitration matters for Admission, Orders and Hearing.
5. On 9th & 10th August 2018, the Division Bench comprising Hon'ble the Acting Chief Justice and Hon'ble Mr Justice Tashi Rabstan is reconstituted and instead of Hon'ble Mr Justice Tashi Rabstan Smt. Sindhu Sharma (Judge designate) is made Member of the said Bench to hear the cases listed before the Division Bench No.1 during the 1st half of the day.
6. The Single Bench matters listed before Hon'ble the Acting Chief Justice on 7th August, 2018 and those listed before the Single Bench presided over by Hon'ble Mr Justice Ali Mohammad Magrey on 7th of August, 2018, shall stand over with liberty to the counsel/parties to make request before the concerned Bench for early listing of urgent matters.
7. The Single Bench matters listed before the Bench presided over by Hon'ble Mr Justice Tashi Rabstan during the 2nd half of 9th & 10th of August, 2018 shall be taken up by the same Bench at 10.30 a.m.
