- 1. Very Good Afternoon to all of you present here.
- 2. I consider it to be my proud privilege to have this opportunity to express my gratitude to all of you on this auspicious occasion of the Foundation Stone Laying Ceremony of the New High Court Complex of the Union Territories of Jammu and Kashmir, and Ladakh, at its new site, namely, Rakhi Gund Aksha, Bemina, Srinagar.
- 3. Recapitulating to mind what we have faced and witnessed a few decades earlier, when we were caught in the worst ever dark period of extreme agony, despair and uncertainty, I am overwhelmed by the joy of not only witnessing but participating in this memorable occasion which, I am sure, will be a milestone in the direction of a great future awaiting the people of the two Union

Territories. I feel proud to be a member of the judicial fraternity of the two UTs. Probably all of you may not be knowing that the High Court of J&K and Ladakh has the distinction of being the 7th of the oldest High Courts in the country, having been actually established 94 years back, in the year 1928, the other six being the High Courts of Bombay, Kolkata, Madrass, Allahabad, Karnataka and Patna. It has also the unparalleled distinction of the fact associated with it that the Supreme Court of India for the first and the last time had to, and constituted a 3-Member Special Bench, headed by the then Hon'ble Chief Justice of India, to hold its sittings outside its ordinary place of sitting at Delhi to hear and decide 17 appeals at Srinagar which were then pending adjudication before the Board of Judicial Advisers akin to the privy Council in British India. Since the time of independence the Institution of the Justice Delivery System in the two UTs has progressed by leaps and bounds in all its spheres.

4. The instant site of the new High Court Complex, I understand, would be the fourth in series to relocate and house the High Court eversince its establishment in 1928; the earliest two locations having been in the old Saddar

Court Complex near Lal Chowk and the third one being its present location adjacent to the Assembly Complex. The instant one is, indeed, a huge and spacious project, involving about 500 Kanals / 62 acres of lands and equally a huge sum of money to the tune of one thousand Crore of rupees. All that could not have been possible without the active and keen concern and effort of the local and the Central Government.

This moment, therefore, is undoubtedly of a great significance in the overall developmental and judicial history of the two Union Territories of J&K, and Ladakh, which cannot be let pass without expression of due and sincere gratitude to all concerned whose untiring efforts have culminated into today's unparalleled and tangible achievement.

I express special thanks on behalf of the High Court of J&K and Ladakh and on behalf of the Governments of the two UTs of J&K, and Ladakh, respectively, headed by Hon'ble Shri Manoj Sinha and Hon'ble Shri Radha Krishna Mathur, Lt. Governors; the Institution of Justice Delivery System in the two UTs, headed by Hon'ble Shri Justice Pankaj Mithal, Chief Justice; Presidents and the

Members of the Bar Associations spread through the length and breadth of the two UTs; and the people of the two UTs, to his Lordship Hon'ble Shri Justice N. V. Ramana, Chief Justice of India, to have kindly agreed to and laid the Foundation Stone of the New High Court Complex of the UTs of Jammu and Kashmir, and Ladakh, and to Hon'ble Shri Kiren Rijiju, Hon'ble Minister for Law and Justice, Union of India who has taken keen interest in ensuring timely start of this project for the of J&K and Ladkah, and to their benefit of people lordships Hon'ble Shri Justice Uday Umesh Lalit and Hon'ble Shri Justice Sanjay Kishan Kaul, Judges of the Supreme Court of India, to have agreed to spare their valuable time and be present at, and to grace, this occasion.

7. On behalf of the High Court of Jammu & Kashmir and Ladakh, I am deeply thankful to Hon'ble Shri Manoj Sinha, Lt.
