- 4. Bidder to note that prices are to be quoted in the Format provided in the price schedule formats provided along with the tender without any conditions. Price bids submitted in any other format and conditional price bids will be liable to be rejected. Price bids received in open condition (not in sealed envelope) or kept in any other Part of the bid (i. e, Part I or II) will also be liable for rejection.
- 5. If the outer envelope is not sealed and not marked as required, JK&LHC will assume no responsibility for the Bid's misplacement or premature opening.
