Subject: Corrigendum to e-Tender

Date: 9th of June 2017

Based on written pre bid queries submitted by some of the prospective bidders and the queries raised in pre bid meeting held on 05.06.2017 at High Court Srinagar, the following corrigendum is issued to NIT HC-JK/ET/2/2017 dated 29.05.2017. All other terms and conditions shall remain unchanged.

Objective/Scope

- a. Clause No.8 shall be treated as deleted.
- b. Clause No.9 shall be read as under:

“The output of scanning and digitization will have to be posted to DSpace DMS by the vendor as per the metadata given under this tender document or to be modified by the High Court from time to time.”

- c. Clause No.10 shall be read as under:

“The PDF/A output should also accompany XML output for all the scripts and PDF/A for English script.”

- d. After clause 10, following clause is inserted:

“The PDF/A output will have to be water marked with the image to be provided by High Court of J&K”

- e. Clause No.14 shall be read as under:

“The software and the methodology to be adopted should ensure seamless integration with workflow followed in the High Court which is under migration to Postgres SQL.”

f. Clause No.15 shall be read as under:

“The PDF/A files as scanned and digitized by the vendor will be digitally signable using digital signature software. Digital signature shall be put on the first page of the file by the verifying officer of the court during quality and quantity check”

g. In Clause 19 (III) (c) after data structure following note is attached:

“All 32 fields are mandatory. In case information is not discernable from the record file, an output of “Not available” shall be reflected.”

1.1 Earnest money deposit:

Clause 2 shall be read as under:

“2. The bidders who are registered for services of scanning and digitization with NSIC or with MSME may be considered for exemption from furnishing the tender fee and EMD. In such cases, an attested copy of valid registration certificate from NSIC or MSME, as the case may be, has to be mandatorily furnished.”

Clause 3 shall be read as under:

“In the absence of such certificate, exemption cannot be granted.”

GENERAL CONDITIONS:

a. Clause 7 shall be treated as deleted.

b. After clause 8, following clause is inserted:

“The software solution to be provided for this project shall be open source 'Dspace' implemented in such a manner that conforms to all other requirements of the tender”

c. In Clause 10, FY 2014-15, 2015-16 and 2016-17 may be read as FY 2013-14, 2014-15 and 2015-16.

d. In Clause 11, FY 2014-15, 2015-16 and 2016-17 may be read as FY 2013-14, 2014-15 and 2015-16 and Rs. 2 Crore may be read Rs. 5 Crore.

e. Clause 13 shall be read as under:

“The bidder must be having valid service tax registration and must provide either NOC from the department or latest service tax audit copy.”

f. Clause 14 shall be read as:

“The tenderers are required to quote their lowest per page rate exclusive of taxes for digitization and scanning and taxes shall be charged as applicable at the time of payment(s)”

g. Clause 16 shall be read as under:

“The rates offered shall be valid for a period of 3 years. However, the expected time for completion of project is one and a half years.”

h. Clause 37 shall be read as under:

“The tenderer has to develop and supply two copies each of the software products along with the source code. The software should be in open source technologies and run on ubuntu linux.”

i. At the end of Clause 42, following is inserted:

“The time line for the completion of the project is one and a half year.”

j. Clause 61 shall be read as under:

“The payments of work done on number of pages will be calculated taking into consideration successful completion of all the parameters of those number of page i.e. Scanning, digitization, PDF/A, Digital signature enablement, Watermarking, Dspace porting, XML output etc. as per the terms and conditions.”

k. After clause 64, a new clause is inserted as under:

“65. CCTV set up at digitization site(s) shall be provided by the bidder at his own costs but the record of the footages shall become property of the High Court.”

a. At serial No. 6, FY 2014-15, 2015-16 and 2016-17 may be read as FY 2013-14, 2014-15 and 2015-16 and Rs. 1 Crore may be read Rs. 5 Crore.
