ANNEXURE-C

TERMS AND CONDITIONS

- 1. The prices quoted by the Vendor shall be in Indian rupees, and not be subject to any price escalation. Levies, Taxes if any introduced by The Government will be extra.
- 2. High Court of Jammu and Kashmir reserves the right to split orders and / or accept or reject any quotation as also to alter any or all of the terms and conditions without assigning any reasons thereof.
- 3. High Court of Jammu and Kashmir reserves the right to accept or reject any Bid and to annul the Bidding process and reject all Bids at any time prior to award of Contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for Tendering Authority's action.
- 4. The interested parties are required to submit refundable EMD of Rs. 50,000/-(Rupees Fifty Thousand Only) by Demand Draft.
- 5. The Earnest Money Deposit without interest will be returned to the unsuccessful bidder within seven days of opening of financial bids and to the successful bidder within fifteen days of award of contract.
- 6. The successful Bidder shall at his own expense submit within fifteen (15) working days from the date of Notice of award of the Contract or Prior to signing of the contract whichever is earlier, an unconditional and irrevocable Performance Bank Guarantee (Annexure-C) of an amount equivalent to 5% of Contract value in Indian Rupees.
- 7. No interest shall be payable on the Performance Bank Guarantee.
- 8. Performance Bank Guarantee shall remain valid for the period of warranty.
- 9. The vendor shall be responsible to install the systems in both the wings of the High Court as per the requirement shown in Annexure-C. He shall also be responsible to install the cables wherever required.
- 10.After letter of acceptance is issued but before award of contract, the successful Bidder shall submit an undertaking within the stipulated time that the terms and conditions are acceptable to him.
- 11.Failure of the successful Bidder to agree with the Terms and Conditions of the Bid/Contract shall constitute sufficient grounds for the annulment of the award, in that event, Tender issuing Authority may make the award to the next Best Value Bidder or call for new Bids.
- 12.In case of break down or occurrence of any obstacle in functioning of the specified Computer Hardware items, the Vendor shall ensure that the same is repaired within specified time. In case of failure to repair the same within stipulated time the Vendor should provide equivalent or higher configuration spare replacement, without any additional charges.
- 13. The spare parts for standby or replacement shall be 100% compatible and shall support respective equipment and spare parts are to be made available at site.
- 14. The response time in removing the defect during the period of warranty is 24 hours failing which penalty at the rate of Rs 500/= (Rupees five hundred only) per day per complaint will be levied and recovered from the performance security deposit. In case of inordinate delay in rectifying the defect is noticed, this court shall have every right to repair defective Hardware at Vendor's cost.

- 15.High Court of Jammu and Kashmir reserves the right to terminate the Contract by giving due notice in case of breach of any of the material obligations under the Contract, if committed by the Vendor, during the Contract period.
- 16. The Contract may also be terminated in case of any unsatisfactory service performance during the Contract period with due notice.
- 17. The Synage Tvs are to be aligned to the Case Information Software running in both the wings of the High Court and the vendor shall ensure that the systems are compatible to that software.
- 18.Payment to the vendor shall be made only after installation of all the items in both the wings of the High Court and after their successful run.
- 19.Vendor will seek the payment by raising the bill and submit the same to the Central Project Coordinator e-Courts High Court of J&K. A single bill for whole the items supplied and successfully installed will be entertained.
- 20.In the event of any dispute or difference arising out or touching upon any of the terms and conditions of this contract and/or in relation to the implementation or interpretation thereof, the same shall be resolved initially by mutual discussion and conciliation but in the event of failure thereof, the same shall be referred to the sole arbitrator appointed by Registrar General, High Court of Jammu and Kashmir.
- 21.All Legal disputes are subject to the jurisdiction of Courts of Jammu and Kashmir only, preceded by Arbitration.
