

Tenders should reach to the office of Registrar Judicial, High Court Wing Srinagar by or before **16th June 2021 by 02.00 pm** which shall be opened in presence of the Tenderers or their representatives on **21.06.2021 at 02.00 pm** in the office of Joint Registrar Judicial, J&K High Court, Srinagar, Tenders should be accompanied with the **CDR worth Rs 50,000/-** pledged in the name of **Registrar Judicial, High Court of J&K, Srinagar**.

Terms and Conditions

1. Rent and License fee of Rs 50,000/- per annum
2. No furniture will be provided by the office.
3. Kerosene oil will not be allowed for cooking purpose.
4. Electricity and water charges to be beared by the license holder.
5. Proper cleanness should be maintained and pure and hygienic food of good quality should be provided to the customers.
6. Waiters / helpers should wear proper uniform and maintain discipline.
7. Items / eatables to be served as per **Annexure-A** and approved rate list of the items to be displayed at all times within the canteen.
8. Covid 19 SOP's of UT of J&K and High Court to be followed strictly.
9. The allotment committee reserves its right to reject any quotation without assigning any reasons.
10. The quotations should inclusive all documents viz a viz food license, provision fund license, labour registration, experience certificate, GST clearance certificate.
11. The allottee shall execute an agreement in favour of Registrar Judicial before using premises of canteen undertaking the terms and conditions which may be imposed from time to time and incase he breaches any condition in that event he shall not be allowed to use premises.

Any violation of the above mentioned terms and condition shall make the license liable for cancellation.


