Subject: Failure of allottee advocates of Lawyers' Chambers' to clear their outstanding dues and action resolved against them.

Hon'ble Committee for Allotment of Chambers to Advocates for Jammu Wing, taking serious view of the matter, has considered future course of action in respect of allottee advocates of Lawyers' Chambers', Jammu Wing, who have failed to clear their respective outstanding dues, despite issuance of several notices followed by extension of time for the same.

As resolved by the Hon'ble Committee of Judges, it is hereby enjoined upon all the concerned defaulter allottee advocates of Lawyers' Chambers' as under:

- 1. "That advocates who have not deposited any amount of monthly chamber fee right from the date, they have been allotted chambers till date, (being 68 in nos, as per Annexure-A of this notice) and those who have deposited their dues partially as on March, 2018 (being 26 in nos as per Annexure-B of this notice) are hereby given last and final opportunity to clear their outstanding dues as on August, 2019 (as shown in the annexure), within four weeks time, failing which their license shall stand terminated and possession of chambers allotted to them shall be taken over accordingly on 11.09.2019."
- 2. "That advocates who have deposited their rent dues for the period only upto March, 2018/March, 2019 (being 117 in nos as per Annexure-C of this notice) shall clear their outstanding dues as on August, 2019 (as shown in the annexure), within four weeks time positively.
