#### **MEMORANDUM**

No: <u>33138 /RG/LS</u> Dated: <u>19.07.2023</u>

Whereas, the Hon'ble Supreme Court vide judgment dated 15.12.2022 in the matter of Civil Appeal No. 9322 of 2022 (Arising out of Special Leave Petition(C) No. 32448 of 2018), titled Gohar Mohammad V/s Uttar Pradesh State Road Transport Corporation & others, has inter alia directed the Registrar General of the High Courts to issue distribution memo attaching the police stations to the Motor Accident Claims Tribunals from time to time to ensure the compliance of the M.V. Amendment Rules, 2022.

And, the Investigating Officer after the registration of FIR shall submit the First Accident Report (FAR) within 48 hours to the Claims Tribunal and Interim Accident Report (IAR) and Detailed Accident Report (DAR) subsequently within the time limits subject to the compliance of the provisions of the Rules.

Now, therefore, the police stations of the Districts of UT of J&K and UT of Ladakh shall be attached to the Motor Accident Claims Tribunal as specified below:-
