It is for the information of all those candidates who have applied for the posts of Driver-II and Driver Grade-I in the pay level-2 (Rs. 19900-63200) & pay level SL-I (Rs. 14800-47100) respectively, in the High Court of Jammu and Kashmir pursuant to Advertisement Notification No. 01/2020 dated 18.09.2020 that their driving test is scheduled to be held on the dates and at the venue indicated in *Annexure-"A" & "B"* to this notification.

Instructions for the Driving Test:

- I) The driving test shall start at 9:00 am on each day of the test, however, candidates shall report at the venue one hour before the scheduled time of the test.
- II) The candidates shall bring the original driving license, qualification certificate alongwith their self attested photo-copies.
- III) Driving test will be conducted only of those candidates whose driving licenses are found valid and possess the requisite qualification.
- IV) For identification purposes apart from driving license the candidates shall also produce either of the following as ID proofs:
 - a) Adhar Card;
 - b) Election Card;
 - c) Passport.
- V) At the venue of driving test, the candidates shall strictly adhere to the Covid-19 SOPs in vogue issued by the Central/UT Government from time to time.
- VI) No TA/DA shall be paid to the candidates.
- VII) Any request for the change of date/venue shall not be entertained except in case of candidates resident of UT of



Ladakh, who can apply only for the change of centre three days before the otherwise schedule date of their test.


Criteria:

The candidates are informed that selection shall be made on the basis of following criteria;

- i) Driving test : 20 points.
- ii) Interview : 20 points.
- iii) Experience : 20 points (upto a maximum of 10 years with allocation of 2 points for each year of experience).


