 - ii) All the Presiding Officers before whom the new appointees have to join are directed to check all testimonials of new appointees and get them verified from the concerned issuing authorities.
 - iii) All the Presiding Officers, before whom the new appointees have to join, are directed to get the character and antecedents of the new appointees verified from the Inspector General of Police, CID, Jammu & Kashmir.
 - iv) The new appointees are directed to give an undertaking before the Presiding Officer at the time of their joining in the shape of affidavit duly attested by a Judicial Magistrate Ist Class to the effect that in case any adverse report about his /her character and antecedents is received from the Inspector General of Police, CID, Jammu & Kashmir in that event his/her appointment shall deem to be cancelled ab-initio and shall have no claim on his/her appointment.
 - v) The salary of the new appointees shall not to be drawn unless a satisfactory report in respect of (ii) & (iii) above is received by the concerned Presiding Officer.
- Any transfer order/attachment order, issued by any Ld. Principal District Judge of a district, which is contrary to this order shall be deemed to have been superceded by B) this order.
