In view of the spread of COVID-19 in the Union Territories of Jammu and Kashmir and Ladakh and in connection with the Annual Darbar Move, Summer Session-2020 of the High Court of J&K, it is hereby notified and ordered as under:

- The Main Wing of the High Court of J&K and the Office of the Registrar Vigilance, High Court of J&K shall close at Jammu on 26th June, 2020 (Friday) after the office hours and reopen at Srinagar on 6<sup>th</sup> July, 2020 (Monday).
- ii. For the time being the Main Wing and the office of the Registrar Vigilance shall continue to remain functional both at Jammu/ Srinagar and the move employees shall work on "as is where is" basis i.e., Kashmir based staff shall work from Srinagar and Jammu based staff shall work from Jammu.
- iii. The Jammu based employees will attend the office at Jammu w.e.f. 30<sup>th</sup> June, 2020 (Tuesday). The Kashmir based employees working in the Main Wing who are already at Srinagar shall report at High Court, Srinagar on 29<sup>th</sup> June, 2020 (Tuesday) with the directions to set the record for smooth functioning of the office.
- iv. Registrar Computers shall put in place robust online/ electronic/ video conferencing other communication mode at Jammu and Srinagar to ensure a virtual office at both places.
- v. Director Finance, High Court of J&K shall draw Special Move T.A. at a uniform rate of Rs. 25,000/- (Rupees Twenty Five Thousand only) and be paid to the move employees strictly in terms of Government Order No. 645-JK(GAD) of 2020 dated 12.06.2020 read with Office Memo No. GAD(Adm)13/2020-III dated 23.06.2020.
