- Note 6: Cases involving Senior Citizens (60 plus) as party or parties thereto and old cases filed up to the year 2010, shall be listed on priority. Registrar Judicial shall give them due preference under the caption "Senior Citizens' Cases" &"Old Cases" respectively.
- Note 7: Special Bench(s), if any constituted in addition to the Roster Benches, shall be convened in second half of the Friday.
- Note 8: If the listed matters related to personal liberties are not taken up for any reason in first half of the day in that event these matters shall be taken up by the concerned Benches at the beginning of the post lunch-session as per the convenience of the concerned roster bench.
