

- Note 2: If for any reason, Hon'ble Judge sitting in the Division Bench has to sit in Single Bench, in that case, the Registrar Judicial, Srinagar/Jammu, shall solicit appropriate orders from Hon'ble the Chief Justice regarding listing of the cases.
