

HIGH COURT OF JAMMU AND KASHMIR (Office of the Registrar General at Jammu)

ORDER

No: <u>949</u>

Dated: 02.01.2016

Sanction is hereby accorded, in the first phase, to the allotment of 205 Chambers mentioned in Column 4 of Annexure-A to this Order, to the groups of Lawyers detailed in Column 2 of Annexure A. The Lawyer named at serial No.1 of each group shall be the main allottee of the Chamber and all others shall be the co-allottees with him. The allotment shall be subject to the following terms and conditions:

- That the allotment would be on license basis, initially for a period of two years extendable for such period and on such conditions as may be determined on the expiry of the said term.
- The main allottee shall be the Incharge of the Chamber allotted to the group and shall be responsible for the same.
- 3) The possession of the Chamber shall be handed over to the group through the main allottee, after each allottee, that are the main allottee and the co-allottees (hereinafter to be referred to as "allottees") of a Chamber make a declaration that he/she is not the member of any other group of allottees.
- 4) That a monthly licence fee of Rs. 200/- shall be paid by each allottee and it shall be deposited with the Registrar Judicial, High Court Wing Jammu (hereinafter to be referred to as Registrar Judicial, Jammu).

Collection of the license fee and its deposit with the Registrar Judicial, Jammu, shall be the responsibility of the main allottee and allotment of an allottee shall be liable to be cancelled in case license fee is not paid for three consecutive months.

- 5) That the main allottee of the Chamber shall be responsible for obtaining independent electricity connection for the Chamber and due payment of electricity dues.
- 6) (i) That the Demand Drafts deposited towards the allotment fee along with the application for allotment shall be encashed and the amount so realized shall be kept in a fixed deposit in the name of Registrar Judicial, Jammu, for an initial period of ten years.

- (ii) That the monthly license fee received from the allottees shall be credited to saving account to be opened in the name of Registrar Judicial, Jammu.
- (iii) That the aforesaid amount shall be used only in connection with the maintenance of the Chambers, upkeep of the building and the related infrastructure including the engagement of man power.
- (iv) That a Committee headed by the Registrar Judicial, Jammu and comprising of President and Secretary of the Bar Association, Jammu, besides a designated Senior advocate to be nominated by the Chief Justice from time to time, to be called as "Maintenance Committee" shall be constituted for maintenance, upkeep of and looking after the affairs related to the Chambers and Building thereto.
- (v) No expenditure from the aforementioned deposits shall be made without the approval of the Maintenance Committee.
- 7) That the Chamber allotted shall not be used for any purpose not connected with the legal profession.
- 8) That each group shall execute an agreement with Registrar Judicial, Jammu, agreeing to the aforementioned terms and conditions.
- That the timings of use of Chambers shall be as under:
 w.e.f. 1st of May to 31st October 7.00 a.m. to 8.00 p.m.
 W.e.f. 1st of November to 30th April 9.00 a.m. to 6.00 p.m.
- 10) That the Registrar Judicial High Court Wing Jammu, shall be overall Incharge of the Lawyers' Chambers' building and responsible for its maintenance and upkeep.
- 11) That the officer of the Registry, discharging duties of the Estate Officer, shall discharge such duty in respect of the Lawyers' Chambers building as well.
