**ORDER**

Consequent upon passing of the prescribed shorthand and transcription test amongst all the eligible candidates of Jammu Province and considering over all satisfactory merit, ability and suitability, Shri Ravi Dutt Sharma, Junior Scale Stenographer, PDJ Court, Samba and Shri Jagdish Raj Kotwal, Junior Scale Stenographer, CJM Court, Doda are hereby temporarily promoted as PA-cum-Senior Scale Stenographers in the grade of Rs. 9300-34800+ Grade Pay 4600.

- 7) Shri Rajesh Kumar, PA-cum-Senior Scale Stenographer, Principal District & Sessions Court, Kathua and Shri Jai Kumar, PA-cum-Senior Scale Stenographer, Special Judge Anti-corruption Court, Jammu shall swap their place of postings.
