As you are aware, reduction of arrears and expeditious disposal of cases was one of the important items on the agenda during the joint Conference of Chief Ministers of States and Chief Justices of High Courts. A number of initiatives taken in this regard in the recent part include setting up of Arrears Committee in the High Courts, preparation of action plan to clear the backlog of cases pending for more than 5 years and promotion of alternative mechanisms of dispute resolution. Further, a large number of cases have been cleared during the Mega Lok Adalats held during the year.

A number of questions during the parliament sessions relate to pendency of cases. Information in this regard is being periodically collected from the High Courts in respect of cases pending in the High Courts as also in the District and Subordinate Courts under their jurisdiction.
