**Subject:** Rejection/Cancellation of candidature of candidate for the post of Librarian, Level-4 (25500-81100) Advertised pursuant to High Court Advertisement Notification No. 02 of 2024/RR/RC dated 09.05.2024 read with Corrigendum dated 29.07.2024.

Whereas, pursuant to the Advertisement Notification No. 02 of 2024/RR/RC dated 09.05.2024, read with Corrigendum dated 29.07.2024, online applications were invited for filling up of various posts including two (02) posts of Librarian, Level-4 (25500-81100).

Whereas, the Online CBT Examination for the said post was conducted on 15.10.2024, both at Jammu and Srinagar.

Whereas, upon the scrutiny of the documents submitted by the candidates, it was found that one of the candidate namely ***Bashir Ahmad Malik S/o Gh Ahmad Malik (Roll No. 600216)***, who was, otherwise, in the consideration zone for the post of Librarian, Level-4, had submitted the experience certificate of "***vocational trainer in the Trade of Media and Entertainment***", instead of the requisite experience of one year as Librarian, to be possessed by a candidate which is mandatory for the aforementioned post, in terms of the relevant Rules.

Whereas, detailed report was sought from the Principal, Government Higher Secondary School, Drung, Budgam, who vide his Office Communication dated HSSD/24/Estt.597 dated 20.11.2024, has verified that the above candidate namely ***Bashir Ahmad Malik S/o Gh Ahmad Malik***, has been working as a Vocational Trainer for the trade Media and Entertainment in the concerned institution.

Whereas, the matter was placed before the Hon'ble Committee for Appointment and Promotion of Officials/Officers of the High Court Staff and as recommended by the



said Hon'ble Committee and approved by Hon'ble the Chief Justice, it is hereby notified for information of all that the candidature of candidate namely **Shri. Bashir Ahmad Malik S/o Gh Ahmad Malik (Roll No. 600216)**, for the post of Librarian, Level-4 (25500-81100) stands rejected/cancelled on the ground of non-possession of the requisite mandatory experience of one year as Librarian to be possessed by a candidate for the aforementioned post and submitting a false certificate alleged to be issued by the above institute.
