- 4. Whereas, vide High Court Notification No. 3170 of 2024/RG/GS dated 24.12.2024, a list of Advocates/Candidates having deficiency of documents was notified and the concerned candidates were asked to remove the deficiency within stipulated time frame. Whereas, the following four candidates namely Sajid Ahmad Gojarchechi, Abdul Majid, Gowsia Farooq Khan and Bikramdeep Singh, have failed to remove the requisite deficiency within the prescribed time frame. As such, as recommended by the concerned Hon'ble Committee duly approved by the Competent Authority, the candidature of the above mentioned four Advocates/Candidates for the post of District Judge (Entry Level), stands rejected.
