Sanction is hereby accorded to the temporary appointment of **Shri Sheikh Mufeez Jeelani S/o Late Sheikh Ghulam Jeelani (Ex-Sr. Scale Stenographer) R/o Zafran Colony, Zewan, Pantha Chowk, Srinagar as Orderly in the Pay Level SL-1 (14800-47100)** on compassionate grounds under and in terms of Jammu & Kashmir Rehabilitation Assistance Scheme – 2022 and is posted as such in the District Cadre Srinagar, against the available vacancy.

His appointment is, however, subject to the following conditions:

- i) *The appointee shall join before the Principal District & Sessions Judge, Srinagar within a period of 21 days from the date of issuance of this order, who shall get all the testimonials and character/antecedents of the appointee verified from the concerned authorities;*
- ii) *The appointee shall give an undertaking in the shape of an affidavit duly attested by a Judicial Magistrate 1st Class to the effect that in case adverse report about her character and antecedents is received from the Police/CID, to whom a reference shall be made by the concerned Presiding Officer, her appointment shall be deemed cancelled ab-initio and she shall have no claim on his appointment.*
- iii) *The salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (i) & (ii) above is received.*


