**NOTICE INVITING QUOTATIONS FOR PROVIDING TECHNICAL MANPOWER
WITH LOGISTIC AND INFRA SUPPORT FOR DEVELOPING E-CERTIFIED
COPY SOFTWARE FOR BOTH THE WINGS OF HIGH COURT OF J&K AND
LADAKH**

On behalf of the Registrar General High Court of Jammu and Kashmir and Ladakh, sealed quotations are invited from eligible companies/firms/entities for providing **Technical Manpower with logistic and infra support for developing e-certified copy Software for both the wings of High Court of J&K and Ladakh** and its implementation by or before 30th January, 2025 with integrated feature of generating notices through AI regarding status of the e-Application filed for e-Certified copy on Display Boards in both the wings of the High Court. The same shall include a provision for **AMC for five years**. The e-Certified Software shall be developed and implemented to ensure the workflow as per the tentative structure in **Annexure-A** with such improvements suggested by the technical team of the High Court from time to time in the course of development and implementation of the Module to synchronise the same with CIS, ICJS and other applications used or to be used in the High Court. The quotations affixed with Rs. 500 stamps shall be submitted **by or before 13th January, 2025 by 11 AM** in the office of Central Project Co-ordinator High Court of J&K and Ladakh at Srinagar/Jammu in sealed cover and copy of the same shall be submitted through mail on [**cpc-jk.lhc@ajj.gov.in**](mailto:cpc-jk.lhc@ajj.gov.in)

Eligibility:

1. The Company/firm/entity must have an expertise in developing, deploying and implementing software;
2. The Company/firm/entity offering quotations must have already executed atleast **three** identical projects of **10 lacks each or above** with the Government;
3. The Company/firm/entity offering quotations must have the necessary logistic, infrastructure and technical expertise;

4. The Company/firm/entity offering quotations must be financially stable.
5. The E-Certified Software must be developed, deployed and implemented in the High Court of J&K and Ladakh by or before 30th January, 2025.

Scope of Work:

The selected entity/company/firm will be responsible for providing technical manpower with logistic and infra support for developing e-certified copy Software, including:

1. Providing skilled technical personnel for developing the Software App of e-Certified copy with Acknowledgement as per the requirement of the establishment and suggestions made by the technical team of the High Court from time to time in the course of development, deployment and implementation;
3. Providing infra support, including hardware, software, and networking requirements;
4. Ensuring that the Module developed works seamlessly in compatibility with the software in use in the High Court;
5. Ensuring that the services/support are provided on site/in the premises.

Evaluation Criteria:

1. Technical expertise and experience (40 points)
2. Financial stability and viability (10 points)
3. Infrastructure and resources (20 points)
4. Price and cost-effectiveness (30 points)


Submission of the Quotations:

2. The quotation should be valid for a period of 30 days from the date of its submission;
3. The quotation should include a detailed break-up of costs under different head components/sub components;
