Pursuant to the directions passed by the Hon'ble Supreme Court of India vide order dated 22.04.2025, in Suo Moto Writ Petition (Civil) No. 7/2024 (In Re: Compensation Amounts Deposited With Motor Accident Claims Tribunals And Labour Courts), the High Court of Jammu & Kashmir and Ladakh has been pleased to direct the Motor Accident Claims Tribunals (MACTs)/Courts dealing with MACT cases where there are no designated MACTs, and the Commissioners under the Workmen's Compensation Act, 1923, to initiate a massive drive with the assistance of the District Legal Services Authorities, Taluka/Tehsil Legal Services Committees and para-legal volunteers to ascertain the whereabouts of the persons who have been held to be entitled to receive compensation, but have not taken the same.

This Notification shall come into effect immediately.
