

Whereas, in terms of High Court order 760/Psy Dated 23.05.2025, the appointment order was issued in favour of 26 candidates as Steno-Typist for Kashmir Division after completion of the Selection process.

Whereas, the newly appointees, vide High Court order No. 782/Psy Dated 28.05.2025, were directed to join their place of postings within the period of 15 days from the date of issuance of order with the rider that any appointee who fails to join within the stipulated period, in that event his/her appointment shall be deemed to have been cancelled without any further notice.


 **Whereas**, the concerned Principal District & Sessions Judges were asked to intimate the reporting/non-reporting of the appointees in their respective Districts.

Whereas, the concerned Principal District & Sessions Judges of Kashmir Division intimated that out of 26 candidates appointed, 09 candidates failed to report/ join for duties in their respective Districts within the stipulated period.

Whereas, the matter was placed before the Competent Authority and his lordship was pleased to **cancel *ab initio*** the appointment of the above referred 09 candidates and also directed the appointment of other candidates from the Waiting List in place of cancelled appointees under rules.

Now, therefore, taking into consideration the above facts, the appointment of 09 candidates to the post of Steno-Typist, who figure in **Annexure-B1** to this order, is **cancelled ab initio**. Accordingly, the candidates who figure in **Annexure-B2** to this order are **appointed** as Steno-Typist, in place of cancelled appointees, from the Waiting List with their posting / adjustments and subject to conditions/formalities as mentioned in **Annexure-B3** to this order.





- i) ***All the new appointees are directed to join their place of postings within a period of 21 days from the date of issue of this Order. In case any appointee fails to join within the stipulated period in that event his/her appointment shall be deemed to have cancelled without any further notice.***
- ii) ***All the Presiding Officers, before whom the new appointees have to join are directed to check all testimonials of new appointees and get them verified from the concerned issuing authorities.***
- iii) ***In case the candidate fails to produce requisite qualification and category certificate, the appointment of such candidates shall deem to be cancelled ab-initio.***
- iv) ***All the Presiding Officers, before whom the new appointees have to join, are directed to get the character and antecedents of new appointees verified from the Inspector General of Police, CID, Jammu and Kashmir.***
- v) ***The new appointees are directed to give an undertaking, before the Presiding Officer at the time of their joining in the shape of affidavit duly attested by the Judicial Magistrate 1st Class to the effect that in case any adverse report about his/her character and antecedents is received from the Inspector General of Police, CID, Jammu & Kashmir in that event his/her appointment shall deem to be cancelled ab-initio and have no claim on his/her appointment.***
- vi) ***The salary of the new appointees shall not be drawn unless a satisfactory report in respect of (ii), (iii) & (iv) above is received by the concerned Presiding Officer.***
