Scaled tenders affixed with Revenue Stamp of Rs.20/- accompanied by the CDR to the tune of Rs.60,000/- each to be pledged to Registrar Judicial, High Court of J&K and Ladakh, Srinagar, are invited from all the interested and experienced contenders, who are having valid registration certificates(s) i.e. Food License affiliated by FSSAI, Labour Registration Certificate, Five Years Experience Certificate in Govt. Department, Latest GST Clearance Certificate and Last 3 Years ITR Certificate, for running of two canteens, located in the Ground Floor of J&K Bank Building and Lawyers Chamber Building, High Court Wing, Srinagar, for a period of one year, which shall reach the office of the undersigned by or before 11.08.2026 at 2:30 PM subject to the following terms and conditions.

1. That the rent and licensee fee shall be Rs.60,000/- per annum for each canteen.
2. That the furniture shall be arranged by the service provider on its own.
3. That the use of kerosene oil is strictly prohibited and shall not be allowed in canteen premises.
4. That the electricity and water charges shall be borne out by the service provider itself.
5. That the service provider shall keep the canteen clean and hygienic food and catering series to be provided shall be of good quality.
6. That the rate of the eatable items to be served as per the **Annexure A**, shall be as per the approved rate list.
7. That the man power including the catering staff and waiters shall be in proper uniform and shall maintain discipline.
8. That the rates as well as the quantity shall be mentioned on the menu for information of consumers/customers strictly as per the approved rate list.
9. That the rates quoted shall be inclusive of GST.
10. That the net weight should be exclusive of weight of wrapper, box and carry bag under all circumstances.
11. That the approved rate list shall be displayed at the conspicuous places in the canteen premises.
12. That the quantity of standard of preparation shall be as per the FSSAI Act 2006.
13. That the food items shall be as per the quality standards laid down under FSSAI Act 2006.
14. That the service provider shall issue proper bills to the customers.

The intending tenderers are expected to fulfil all the stipulations as mentioned herein above before submitting the tenders with this office. It is to be noted that the tenders will be opened in presence of the tenderers or their representatives on 18th August, 2026 at 2:00 PM in the office of the Registrar Judicial, High Court of J&K and Ladakh, Srinagar.
